

## Terms and Conditions: 48-hour test drive - Splend

By participating in our 48-hour test drive program, you agree to the following terms and conditions:

**Documentation Requirements:** To commence the test drive, you must provide a current driver's license, PCO license, and proof of address. Photocopies of these documents are mandatory.

**Insurance Approval:** Your eligibility to participate in the test drive is subject to successful insurance checks and meeting our underwriting criteria.

**Single Driver:** Only one potential member will be granted use of the vehicle during the test drive period.

**Privacy Statement**: You consent to the collection and use of your personal information in accordance with the dealership's Privacy Statement. Your information may be stored for the purpose of following up on your vehicle sales inquiry or addressing any accidents or financial losses arising from your use of the vehicle.

**Accuracy of Information:** You acknowledge that the information supplied is accurate and commit to abide by the stated conditions.

**Lawful and Responsible Driving:** You agree to drive the vehicle in a lawful and responsible manner, adhering to all government motoring regulations.

**Driver's Eligibility:** You hold a valid Full UK driving license for the DVLA category of the vehicle, and you are neither suspended nor disqualified from driving for any reason. You also confirm that you are not under the influence of drugs or alcohol nor will be throughout the course of the test drive.

**Safety and Cleanliness:** You are responsible for the safety of the vehicle and its passengers and agree not to smoke inside the vehicle.

**Financial Responsibility:** You accept responsibility for any damage and will cover tolls, fines, infringement notices, including legal costs and expenses that occur while the vehicle is in your control.

**Vehicle Key Handling:** You will keep the vehicle keys under your personal control when not in use and return them to a Splend employee at the designated Splend location when the test drive concludes.

**Accident Reporting:** In case of an accident, you will immediately notify Splend and the police, record and provide the other party's particulars, including contact information, driver's license number, and insurance company details, as specified in the Splend accident exchange card provided.

**Insurance Excess:** You agree to pay the insurance excess in the event of an accident or incident, as detailed in your agreement.

**Prompt Return:** You will return the vehicle immediately upon demand.



**Authorised Use:** The vehicle is authorised for social, domestic, and pleasure as well as private hire use during the test drive period.

**Security Deposit:** A preauthorised £100 will be debited or held from a credit card in your name and registered at your corresponding address. This deposit will be refunded within 14 days post-test drive, subject to any applicable charges.

**Parking Your Current Vehicle:** You agree to leave your current vehicle at the secure Splend pick-up location for the duration of your test drive. The vehicle must be registered to the named person above.

**Administration Fee:** An administration fee of £15 per penalty charge notice received while the vehicle is in your possession will apply.

**Termination:** Splend retains the right to terminate this agreement and the test drive at any point within the test drive period.
